# I. CALL TO ORDER AND APPROVAL OF THE JULY 17<sup>TH</sup> 2013, MEETING MINUTES

## II. OLD BUSINESS

## A) Training Workshops

- i) Trees and the Law Workshop September 20th, 2013
  - (a) All members present at the meeting were asked if there was anything else we'd like to add to the program for the Trees and Law Workshop. Contact Steve Nimz if you would like suggest an additional topic to the agenda.
  - (b) 19 people have already registered. We expect this workshop to be well attended. It will be held at the Ala Wai Golf Course, conference room second floor. 8:00am-4:00pm. Lunch will be provided.
  - (c) Jamilee and Amy will be running the registration table and CEU sign-up sheets.
  - (d) There will be a panel discussion with Steve Nimz, Abner Undan, Mike Krauss, and Kevin Eckert.
- ii) John Ball Workshop 2014
  - (a) There are no new developments. AAA is still working with WCISA regarding this proposed workshop.
  - (b) McCoy Pavilion is scheduled to re-open April 22<sup>nd</sup> 2014. This date is tentative.
  - (c) Big Island is interested in holding the workshop the following Thursday April 24<sup>th</sup> or Friday April 25<sup>th</sup> 2014. AAA is still waiting to hear back from Maui to determine their interest in holding this workshop.

- v) 2014 Hawaii Tree Climbing Competition Tabled
  - (a) AAA still needs to talk with J.P. Damon.
  - (b) We are shooting for the  $3^{rd}$  weekend in February to hold the HTCC 2014.
- vi) ISA Tree Risk Assessment Qualification (TRAQ)
  - (a) AAA sent out a survey to determine Hawaii's interest in taking TRAQ. So far 14 people have replied with interest. This may be enough to hold the TRAQ course. AAA will continue to look into this option.
- vii) Tropical Fruit Phenology Workshop Mark Nickum
  - (a) Details are still in development. The Urban Garden Center could be a possible venue for this workshop.
  - (b) Citrus, Avocado, Lychee, and Mango are some of the most common fruit trees planted in Hawaii. These fruit trees should be covered at this workshop.
  - (c) We may be able to encourage additional speakers for the fruit phenology workshop. Richard Ebesu is one of the authors of Citrus for Hawaii's Gardens and Ken Leonhardt, Professor at UH Manoa could talk about entomology, specifically the pests that effect fruit trees in Hawaii.

- C) New Meeting Venue
  - i) The September 18<sup>th</sup> Meeting is scheduled at the Real A Gastropub 1020 Auahi St. We are going to give Real A Gastropub another try. It was very loud in the downstairs section. We have discussed with the managers and plan to sit upstairs where it will be more suitable to have our meeting next month.

  - i) AAA will reserve a booth at the LICH Conference. We will have the WCC Subtropical Tree Care Program information to hand out. Jamilee and Amy will take shifts to man the booth.

- A) Pest of the Month Update Coconut Rhinoceros Beetle (Oryctes rhinoceros)
  - i) Host: Coconut and Oil palms mainly but also may attack other palm species.
  - ii) Distribution: South Pacific (American Samoa, others) and Guam.

- iii) Damage: V-shaped cuts in the fronds or holes through the midrib.
- iv) Control: Eliminating the places where they breed and manually destroying adults and all stages of life cycle eggs, larvae, and pupae. Also through natural enemies such as pigs, rats, ants, and some beetles and diseases (fungus *Metahizium anisopliae* and *Oryctes* virus).
- B) Membership Cards
  - i) AAA has agreed to start creating membership cards starting January 2014.
  - ii) Yearly members would receive a simple paper membership card to use at workshops and to receive discounts. Lifetime members would receive a laminated card.


